How to Enter the Juried Show

- Select images consistent with the theme title "Elsewhere".
- Submit up to **four images per submission** to be juried: prints, 35mm slides and digital images will be accepted.
- You may submit more than one entry; use the attached submission form for each.
- Send or deliver completed submission form, entry fee and submitted images to Image City Photography Gallery (ICPG) postmarked by November 10, 2007.
- Entry fee is \$25, per submission; paid by check made to ICPG.

Submitted Photographs / Slides / Digital Images

- Photographers may submit a total of four prints, slides or digital images per submission for consideration by the ICPG Curatorial Committee, who will make the final selection.
- On the submission form, fully describe the dimensions of the photograph and dimensions of matted and framed presentation for your submitted images.
- Prints for submission should be at least 8x10 inches in size.
- Slides must be 35mm, 2 x 2 in. cardboard or plastic mounts. Glass slides are not acceptable.
- Digital images must be submitted as JPEGs on a CD-Rom and must be at least 300 dpi in finished sized of at least 5 inches by 7 inches. Emailed images will not be accepted.
- Each print, slide, or CD must be labeled with the artist's name, and title of work, with TOP clearly marked. Unlabeled submissions will be disqualified.
- Deliver or mail submissions to ICPG, at the address below and must be postmarked by November 10, 2007.
- Submitted entries will not be returned unless a SASE is included and ICPG is not responsible for any damage during return shipping. They may also be picked up at The Gallery within two months following the selection, prior to February 24, 2008.

Notification of Acceptance

- Notifications of acceptance will be mailed by November 26, 2007.

Conditions of Entry

- The submitted images must have an element of photographic origin.
- All entries must be of original design and personal execution.
- Accepted work must be received installation-ready with quality frame (e.g. Nielsen), appropriate hanging device, installation instructions, and it **MUST** be clearly labeled on the back with artist's name and title of the work.
- Accepted work may not be withdrawn before the close of the exhibition on January 27, 2008.
- ICPG will retain a 30% commission on all sales made during the exhibition. An insurance value and a sale price, which includes commission, must be included on the submission form.
- The curatorial committee and ICPG reserve the right to refuse any entry because of special conditions of installation or if the quality of the work was not accurately represented in the submitted image.

Liability / Delivery / Retrieval

- ICPG will insure photographs while on site at the Gallery for the insurance value indicated on the submission form. Insurance for the photograph during shipping and transit to the Gallery is the responsibility of the entrant.
- All accepted photographs must arrive by December 23, 2007 at 4 pm **ready to hang**.
- Artists are responsible for all shipping costs including insurance. Work must be shipped in a substantial, reusable container. The Gallery will not be responsible for any damage that occurs during shipping. Hand delivery will be accepted from December 19 to December 23, 2007 during Gallery hours: Wednesday – Saturday, 11 am – 7 pm, Sunday, noon – 4 p.m.
- Prompt retrieval of photographs after the exhibit will be gratefully appreciated. Photographs must be picked up January 27 from 4 – 7 pm or during Gallery hours January 30 – February 24, 2008. If not picked up at the Gallery, arrangements for packaging and shipping photographs are the responsibility of the photographer. ICPG will not be responsible for submitted images or accepted prints not retrieved by February 24, 2008.
